Powers and functions of Governing Body:

Governing Body

The Governing Body of the university has, inter alia, members drawn from the industry, University and experts from academic field. The Governing Body gives direction to the university management.

- i. Provide general superintendence and to give directions for controlling the functioning of the University in accordance with the statues, ordinances, and regulations;
- ii. The Governing Body shall meet twice in a calendar year.
- iii. The quorum of the Governing Body shall be five.
- ii. Review the decisions of other authorities of the university in case these are not in conformity with the provisions of the statues, ordinances, and regulations;
- iii. Approve the budget and annual report of the University;
- iv. Lay down the extensive policies to be followed by the University;

- iii. Approve the budget and annual report of the University;
- iv. Lay down the extensive policies to be followed by the University;
- v. Exercise such other powers, as may be prescribed by the statues;
- vi. Formulate academic aims and objectives of the institution and guide the institute towards the achievement of the same.
- vii. Examine and consider the recommendations of working committees in the university and prepare a road map for achieving the goals of the Institution.
- viii. Monitor academic, research and other related activities of the Schools and guide them in the correct direction.
- ix. Consider the recommendations of the staff selection committee and approve the same.
- x. Consider the important communications, policy decisions received from the University, State and Central Government, AICTE, and UGC etc.
- xi. Encourage and facilitate Schools and University to apply for accreditations / Certifications, if any
- xii. Facilitate and encourage faculty members to apply for research projects/proposals
- xiii. Monitor the student and faculty development programs and guiding the schools appropriately so that they achieve the end objective.
- xiv. Facilitate starting of new UG/PG programs, deciding on discontinuing any existing programs and increase/decrease intake into any UG/PG program.
- xv. Facilitate checking the audited income and expenditure accounts and approve the same for the university annually.

xvi. Consider and facilitate college to resolve legal/court cases, if any.
