I. GUIDELINES

The 4th Dr. B.R. Ambedkar Moot Court Competition (offline) has been organized by School of Law, CT University, Ludhiana.

Eligibility Criteria:

The Competition shall be open for 'bonafide' students who are pursuing an integrated 5 Years or 3 Years Law

Program in India from an institution recognized by the Bar Council of India.

Language & Dress code:

Language shall be English and the dress code shall be formal.

a. **Ladies:** White Shirt and black Pant/black skirt or White Salwar and Kurta along with black coat and black shoes.

b. **Men:** White shirt, black trousers, black tie along with black coat and black shoes.

Team Composition:

1. Each team shall consist of 3 Students (1st as speaker, 2nd as speaker and 3rd as researcher).

2. Each team should identify such speakers and researchers at the time of registration.

3. Researcher is not permitted to speak except under special cases and only with the express permission of Organizers/judges.

4. There shall be no substitution of any team member after a team has submitted its Registration form, except with the permission of the Organizers

REGISTRATION

1. All interested teams shall have to make payment of registration fees amounting to INR 3,000 (with accommodation), 2,000/- (without accommodation) /- (non-refundable) in the account given below:

3. Forms received after the deadline shall not be considered for registration.
4. The receipt of form shall be acknowledged within 48 hours of submission via official mail.
5. Registration of a team shall be confirmed only after receipt of payment and registration form by the organizers. (confirmation of registration shall be conveyed via official email only.)
6. Upon validation of registration, each team shall be allotted a team code before the competition. During the competition the team shall be identified by the team code allotted to them.

MEMORIAL

1. Each team participating in the Competition must prepare a memorial on behalf of the Prosecutor/ Applicant/ Petitioner and on the behalf of the Defendant/Respondent.
2. Each team must send its memorandum via e-mail in both, PDF and Word formats, latest by 26th March, 2025 by email. All the memorials shall be mailed on the Official Email- mcc2025@ctuniversity.in with the subject of mail being "Memorial Submission-'Team Code'". Example Subject of the mail for Memorial Submission of Team Code 01 shall be "Memorial Submission - TC01". In case the subject is not as prescribed, memorials shall be deemed to have not been received and the Organizers shall not be responsible for any delay and default.

3. The Memorials shall consist of following:

- a. Cover Page
 - b. Table of Contents
 - c. Index of Authorities
 - d. Statements of Jurisdiction
 - e. Statement of Facts
 - f. Statement of Issues
 - g. Summary of Pleadings
 - h. Argument Advanced
 - i. Prayer Clause
4. Memorials shall be typed on A4 size paper having one inch margin on all the sides.
 5. The font shall be Times New Roman, font size being 12 and line spacing shall be 1.5 for footnotes, font size shall be 10 with line spacing of 1.0.
 6. Page numbering shall be at bottom & at the center of each page

7. The memorials must state the TEAM CODES on top right of each page in the following manner:
For Prosecutor/Applicant/Petitioner's Memorial: P- *Team Code*
For Defendant/Respondent's Memorial: R- *Team Code*
8. Participants must follow the Bluebook 20th edition style of citation.\
9. The Cover page of the Memorial for the Prosecutor/Applicant/Petitioner must be BLUE, while for the Defendant/Respondent's Memorial, it must be RED.
10. The Cover page shall Include:
 - a. Name of the Competition
 - b. Name of the Court
 - c. Cause Title
 - d. The Cover page must specify either "Memorial for Prosecutor/Applicant/Petitioner" or "Memorial for Defendant/Respondent".
11. The total number of pages of the memorials must not exceed thirty (30). Exceeding the limit, the memorial shall attract negative marking of one (1) point each for every additional page.
12. Compendium or any other references are optional and must be submitted to the Organizers through mail at the time as that of submission of the memorial. Only one Compendium to be submitted from each side, for easy accessibility of the judges.
13. Further, for semifinals and final round the compendium for both the sides must be submitted.
14. Once the written submissions have been submitted, no revisions, supplements, or additions will be allowed.
15. The participating teams shall submit the memorials online via the official mail on or before 26th March, 2025. The teams shall carry four hard copies of memorials for both the sides.
16. Submission of the Memorials after the specified deadline shall result in a deduction of five (5) marks each day. Failure to submit a memorial would result in disqualification of the team from the competition.
17. Each team shall be provided with the copy of the written submission of the opponent team prior to the respective rounds.
18. The Organizers of this Competition shall be permitted to use all the Memorials for any reporting or compilation without further permission. The Submission would be deemed to be permission. Moreover, the copyright in the prize-winning Memorials would be vested with the Organizers

II. STRUCTURE OF THE COMPETITION

1. The Moot court Competition shall comprise of following rounds:
 - a. Preliminary Rounds
 - b. Quarter Final Rounds
 - c. Semi-Finals Rounds
 - d. Final Round
2. After the orientation of the teams, the draw of lots shall take place and the team has to argue on behalf of both sides, the Prosecutor/Applicant/Petitioner and the Defendant/ Respondent in the preliminary rounds.
3. Top 8 teams, based on the cumulative score of memorials and preliminary rounds, shall qualify for the quarter Finals. Further, the top 4 teams, based on the results of the quarter final rounds, shall qualify for the semi-final rounds. Finally, the top 2 teams will be selected for the final round.
4. In case of tie, highest memorial marks will be taken into consideration to decide the winner

A. DRAW OF LOTS

Before the Preliminary, Quarter Final, Semi-Final and Final rounds, draw of lots shall be done to determine the side on which the team shall be arguing. The Teams shall be mailed the memorial files (Appellant/Respondent) for each round. Further, the Teams shall also be mailed the copy of their opponent's written Submission prior to the oral rounds.

B. ORAL SUBMISSIONS

- a. As specified herein above, each team shall have two speakers who shall further divide the oral submissions between themselves.
- b. At no point of time during the Competition, any speaker shall reveal their identity.
- c. Any compilation or detailed pleadings will not be entertained. The participants are requested to bring with them the authorities/case laws on which they want to rely during the arguments.
- d. At the commencement of each round of Oral Submissions, each team shall notify the Court Officer the division of time between the two speakers. Further, each team must notify the Court Officer the amount of time that the team wants to reserve for their rejoinder / sub-rejoinder. A maximum of 5 minutes may be reserved for the rejoinder/ sub-rejoinder.
- e. Only one speaker from each team shall be permitted to rejoinder / sub-rejoinder. the sur- rejoinder shall be limited to the rebuttals made by the opponent team.
- f. Five (5) minutes and Two (2) minutes before the completion of the allocated time for each speaker, there will be a warning bell, and at the completion of the allocated time for each speaker there will be a final bell.
- g. In case a speaker continues to speak after the completion of his/her specified time, the additional time which he/she consumes will attract negative marking at the discretion of the judges. The judges shall have all the rights to grant opportunity to rejoinder or sub-rejoinder and to allocate additional time. During the course of oral submissions, the participants cannot submit to the court any material containing pictorial representation whatsoever.
- i. If at any instance a submission is made with any material in violation of rules and if any picture, sketches, photos, cartoons, caricatures, audio film, video film, projector-slide or a computer-generated image is used or submitted or presented to the court, the teams shall be subject to disqualification

III. CONDUCT OF COMPETITION

The Competition will be conducted in offline mode here at School of law, CT university, Ludhiana.

1. All the rounds of the competition shall be conducted offline.
2. Any form of communication between the Bar and by any person other than those on the Bench is completely prohibited, and any indulgence in the same shall result in a penalty.
3. Submission of any written material other than the memorials and compendiums in hand to the Bench prior to, during or after oral arguments is not allowed and any indulgence in the same shall result in a penalty. Failure to deliver an oral argument shall be considered in entirety, a disqualification.
4. Use of any kind of electronic devices like laptop, mobile, Tablets etc. is strictly prohibited during the moot proceedings.
5. All participants are expected to maintain the decorum of the Court during the competition and are expected to conduct themselves in a manner befitting the legal profession

III . CONDUCT OF COMPETITION

1. Participating teams may seek clarifications via mail on the Official Email with subject title as 'Clarifications for 4th Dr. B.R. Ambedkar Moot Court Competition (Offline) or telephonically on the numbers provided at the end.
2. The last date to seek clarifications to the Moot Proposition is 23rd March, 2025

1. Strict action shall be taken if scouting is found through a team member or otherwise or through any other unfair means.

3. The Organizers reserve the right to take appropriate action for any unethical, unprofessional, and immoral conduct.
4. The Organizers' decision as regards to the interpretation of rules or any other manner related to the competition will be final and binding.
5. If there is any situation which is not contemplated in the rules, the Organizers' decision on the same shall be final and binding.
6. The Organizers reserve the rights to vary, alter, modify, or repeal any of the above rules if so required and as they deem appropriate

Jury

An eminent jury composed of senior professionals with legal acumen and practical experience shall be constituted to adjudge top Teams. Separate jury should be constituted for each Level of competition.

Memorials

The following requirements must be strictly met for each level. Non-conformities will be penalized:

- a. Each team must prepare memorials (Petition, Reply, Rejoinder & Written Notes) for both sides, i.e. (Petitioner and Respondent).
- b. Once the memorials are submitted, no revisions, supplements, or additions will be allowed.

Procedure for Appearance at the Competition

Scouting:

Teams will not be allowed to observe the orals of any other team(s). Scouting is strictly prohibited. Scouting by any of the teams will result in disqualification.

Scoring/Marking Parameters:

- a. Memorials will carry 30% and oral submissions will carry 70% of evaluation.
- b. If the memorials are found to be verbatim reproduction of each other, no points will be awarded for such memorials.
- c. Procedure for appearance at the competition
Petitioner's Submission - 15 minutes
Respondent's Submission (Counter)- 15 minutes
Rebuttal and sur-rebuttal- 5 minutes

d. Indicative parameters for scores on the basis of Oral Submission:

- i. Knowledge of facts-20 marks
 - ii. Logic, reasoning and clarity-20 marks
 - iii. Deference to the court-10 marks
 - iv. Proper and articulate analysis of the issues arising out of facts-20 marks
 - v. Understanding of the laws directly applicable to the issues-10 marks
 - vi. Ingenuity (ability to argue by analogy from related aspects of law)-20 marks
- e. Indicative parameters for scores on the basis of Written Submissions (Memorials).**
- i. Logical progression of ideas
 - ii. Originality in analysis and arguments
 - iii. Effective use of headings to outline arguments
 - iv. Understanding essential legal issues presented
 - v. Focus on essential (not collateral) issues
 - vi. Clear, concise and unambiguous writing style
 - vii. Forceful and persuasive presentation
 - viii. Integration of facts into legal argument
 - ix. Understanding of strengths and weaknesses of case
 - x. Discussion of viable alternative arguments
 - xi. Understanding and analysis of authority
 - xii. Proper use of citations and citation form
 - xiii. Effective use of authority to support arguments
 - xiv. Ability to distinguish adverse cases
 - xv. Neatness, legibility, typos or format errors

MOOT PROBLEM

1.The Agarwal family, a well-known business dynasty in New Delhi, has been at the helm of Agarwal Industries Ltd., a major player in the consumer goods sector, for over five decades. The family patriarch, Mr. Sunil Agarwal, was the only legal heir of an inherited ancestral Property by way of natural succession and a visionary leader who expanded the business significantly. However, his sudden death in 2014 has led to a contentious legal battle between legal heirs, involving his marital relationships and the future of the family business.

2.Sunil Agarwal (Hindu) married Preesha Samson (Christian) in 2000 and it was performed in New Delhi. Preesha, a Post Graduate with aspirations to pursue a career in teaching, gave up her professional ambitions to support Sunil in his business endeavors. The couple initially shared a harmonious relationship, marked by mutual respect and collaboration.

3.By 2003, tensions arose due to differing Perspectives on family life and business management. Sunil's increasing involvement in the business led to neglect of personal relationships and Sunil was having a problem with Preesha that she is suffering from bi-polar disorder due to which she has attacked him physically several times during this matrimonial relationship. The same fact was not disclosed to the Sunil before his marriage by Preesha and all her family, while Preesha felt sidelined and unappreciated. Due to the result of continued separation, Sunil filed the petition for annulment of marriage before the Family court. Which was decreed in favour of Sunil on 15 Feb 2008. Meanwhile, Meenakshi Gupta, an MBA graduate from a prestigious university, met Sunil at a business networking event on Dec 2006. Their relationship blossomed and believing that his first marriage had ended in practice. Eventually, they got married on 1st March 2008, On the other side, Preesha Samson, feeling aggrieved by this present decision and by contesting the decree, Filed an Appeal on 8 March 2008 in the High Court of New Delhi against the decision of the Family Court.

4.Meenakshi has been a dynamic partner, not only in family life but also in business. She played a pivotal role in modernizing Agarwal Industries Ltd., introducing sustainable practices, and expanding the company's market reach. Her active involvement and dedication have been acknowledged by employees and business associates alike. Meenakshi and Sunil had 2 children, The eldest child Ashu aged 3 years born on March 2009 and Rashi born on Nov. 2012.

5.On 5th March 2014 The sudden demise of Sunil has led to uncertainty about the leadership and future direction of the company. But before his death, Sunil was an executed a will dt. Jan 2014 of his property in favour of Meenakshi.

6.Now, Immediately after the knowledge of the sudden demise of Sunil and being the legal heir of Sunil, Preesha Samson has approached the appropriate jurisdiction of the Civil Court at Tis Hazari in New Delhi, against Meenakshi, Ashu and Rashi to preserve her legal rights.
